Arrest made in KCHS threat

A Knox Central High School student has been arrested after police say he wrote threatening messages on the bathroom walls.

Kentucky State Police Post 10 Harlan was first made aware of the threatening messages on March 1 at approximately 11:45 a.m. Troopers Jay Sowders and Chad Gregory responded to the school and began an investigation.

According to a press release from KSP Public Affairs Officer Shane Jacobs, preliminary

investigation indicates that a 16-year-old male from the Flat Lick community wrote threatening messages on the bathroom walls at KCHS while he was at school on March 1. KSP officers arrested the juvenile, charging him with second-degree terroristic threatening. He was transported and lodged in the Breathitt County Juvenile Detention Center.

This case is still under investigation by Tpr. Jay Sowders. The Knox County Sheriff's Department assisted at the scene.

State Police order threatens media

The order from State Police Public Affairs

Officer Shane Jacobs says, "...from this point forward when KSP is working an investigation, you are to wait until OUR (KSP) press release is sent out before putting anything out on social media. radio, and newspaper. No more posting inaccurate

information from Sheriff's or anyone else." He then threatens, "Authority of my supervisors, if this continues, you will be taken off our media distribution list." (Officer

conference, the jury trial date for James Davis, 21, was set for May 15 at 9 a.m. with the Honorable Michael Caperton presiding. Before his jury trial, Davis will have a ninth pretrial conference

on May 7 at 9 a.m.

Davis allegedly kidnapped 23-year old Douglas "Bub" Middleton from his home in Artemus on February 15. Middleton was located 17 days later, suffering from multiple injuries including severe frostbite which led to the amputation of

Middleton told Kentucky State Police Detective Jake Wilson that Davis kidnapped him from his residence, placed him onto an ATV, took him to a building in the woods and kept him there for 17 days. Middleton

Ross is charged with third-degree rape, which she plead not guilty of, stemming from charges she had sex with a male inmate while she was employed at the jail. Any sexual contact between jail employees and inmates is an automatic third-degree rape charge because the employee is in a position of authority over the prisoner. The charge is a Class D felony, and if found guilty, Ross could serve up to five years in prison.

ancer survivor spreads awareness across region

After winning her own fight with cancer, a local woman is working around-the-clock to raise awareness and support for other cancer patients in Knox County.

Sherry Payne was diagnosed with stage three colon cancer in November 1998. Payne recalls initially thinking the pain she was experiencing as stress-related, but as it increased, she went to her doctor just to be safe.

"It was some of the worst pain I've ever had. I could not get out of bed. I still don't know why I didn't go to the ER, it was that bad," recalls Payne.

After performing several tests which

revealed nothing, Payne's doctor opted for a colonoscopy, something most 44 years olds do not have to worry about.

Payne states that when she went for the colonoscopy, the procedure couldn't be performed.

"When they went in, the tumor was so big, I was completely blocked and that's what was causing the pain," continued Payne, who said if she had waited just two more weeks, she would've become septic and would not be alive

The day following the failed procedure, Payne's doctors confirmed she had cancer and

Knox man arrested in child porn investigation

A Barbourville man was arrested Wednesday and charged with distributing child pornography.

Kentucky State Police's Electronic Crime Branch on Wednesday,

February 28 arrested Robert T. Whitter III, 27 of Barbourville, on charges related to the distribution of matter portraying a sex performance by a minor.

According to a press release from KSP, Whitter was arrested as the result of an undercover Internet Crimes Against Children investigation. The investigation began after discovering the suspect uploading images of child sexual exploitation online.

KSP executed a search warrant at Whitter's residence where they seized equipment for examination they say was used to facilitate the crime. The equipment was sent

Flat Lick woman arrested for fourth DUI

A Flat Lick woman may be facing a felony after police arrested her for a DUI this past week, her fourth since 2013.

On February 27 at approximately 4:46 p.m., the Laurel County deputies and officers were alerted that a gold colored Chevrolet Classic was driving recklessly in London. The vehicle was operated by Chastity J. Roop, 30, of Flat Lick.

Police caught up with Roop, who stated she was weaving because she was texting while driving. During the traffic stop, police determined she was under the influence. Roop was also found in possession of four syringes, rolling papers, a glass pipe and Ziploc bags.

Roop was charged with operating a motor vehicle under the influence (fourth offense), driving on DUI suspended license (third offense), driving a motor vehicle while texting, failure to wear seatbelts and possession of drug paraphernalia. Roop was also wanted for a Laurel District Court bench warrant for failure to appear in court on

charges of operating on suspended or revoked operator's license and numerous other traffic,

registration and insurance violations. Roops previous **DUI** charges come from March 2013, February

2015 and November 2016. In Kentucky, the penalty for a fourth DUI in 10 years is a Class D felony, punishable of up to \$10,000 in fines and/or imprisonment up to five years. Also arrested during

the traffic stop was a passenger in the vehicle, Jason Steven Martin, 33, of Jeffersonville, who gave officers a false name. Martin is charged with giving officer false identifying information. Both individuals were lodged in the Laurel County Detention Center.

Laurel Sheriff's deputies Rick Cloyd, Jake Miller and Travis Napier and London City Police officers Greg Turner, Matt Moore and Steven Sparks made or assisted in making the arrests.
